LICENSE

(under the CC BY-NC-ND 4.0 license)

By exercising the Licensed Rights, You accept and agree to be bound by the terms and conditions of this Creative Commons Attribution-NonCommercial-NoDerivatives 4.0 International Public License ("Public License"). § 1. Definitions

- a. A. License grant

- 1. Subject to the terms and conditions of this Public License, the Licensor hereby grants You a worldwide, royalty-free, non-sublicensable, non-exclusive, irrevocable license to NonCommercial exercise the Licensed Rights in the Licensed Material to reproduce and Share the Licensed Material, in whole or in part, for NonCommercial purposes only
- 2. *Exceptions and Limitations*. For the avoidance of doubt, where Exceptions and Limitations apply to Your use, this Public License does not apply, and You do not need to comply with its terms and conditions.

- 4. Media and formats; technical modifications allowed. 5. Downstream recipients

- b. <u>No downstream restrictions</u>. You may not offer or impose any additional or different terms or conditions on, or apply any Effective Technological Measures to, the Licensed Material if doing so restricts exercise of the Licensed Rights by any recipient of the Licensed Material.
- c. <u>No endorsement</u>. B. Other rights

- 1.
